Select Committee on a Safe, Clean, and Inclusive Community

Dear Members of the Select Committee,

On September 13, 2021, Mr. Todd Corrigall sent an email to Council and City Administration "on behalf of the majority of members from the Mayor's Select Committee for a Safe, Clean and Inclusive Community." I am pleased to respond to the issues identified in the correspondence.

As reflected by the <u>meeting minutes</u> from its January 5 meeting, the Select Committee unanimously approved its Report to Council that included key commitments relating to coordinated advocacy, service coordination, and an evaluation of the City's Downtown Service Enhancement Package. The report had several appendices including:

- Minutes from the December 2, 2019 Council meeting at which Council received public feedback on issues and opportunities to further inform the City's response to the social issues throughout Prince George with a focus on downtown;
- A December 16, 2019 Council Delegation presentation prepared and delivered by the Prince George Chamber of Commerce, Downtown Prince George, and the Gateway and;
- Verbatim data from the September 15, 2020 Select Committee Workshop facilitated by Urban Matters.

The appendices accurately document ideas shared by the public and members of the Select Committee. These ideas, including the development of the Situation Table and "Downtown Public Safety Office," were discussed at the facilitated workshop and informed the commitments approved by the Committee and Council.

The letter forwarded by Mr. Corrigall also referenced a news release that was prepared by the City to announce its receipt of \$1.9 million of funding from the Strengthening Communities' Services grant stream. The news release, attached, does not state that the Select Committee was consulted in relation to the grant application. Rather, the news release acknowledges that the establishment of the Hub was one of the key commitments approved by Council that was contained in the report from the Select Committee.

It is important to note that the City invited agencies including the RCMP, Downtown Prince George, Northern Health, BC Housing, and the Prince George Native Friendship Centre to provide suggestions regarding the City's grant application. These agencies were selected to provide input as their services most closely aligned with the grant criteria that was heavily weighted toward services for the unsheltered homeless and community concerns regarding cleanliness and safety. In relation to "downtown civic security," Administration did act on the Select Committee's advice to reallocate \$400,000 of the Downtown and Area Service Enhancement Package from Civic Facilities for security costs to Bylaw Services to enable the hiring of four additional Bylaw Enforcement Officers. Council approved the reallocation in January, which means there is a Bylaw presence in the downtown and area seven days per week from 7:00am to 11:00pm.

However, the need for security - particularly in city parkades - continued and, in fact, greatly increased through the COVID-19 response period. The Strengthening Communities grant is intended to support local governments by providing bridge funding for the period between the COVID-19 outbreak and the post-COVID recovery period. As a result, the City was able to retroactively claim the security expenses it incurred to keep members of the public safe when utilizing the parkades.

The City of Prince George extended the term of the Select Committee to ensure its ability to provide updates as the City proceeded, in partnership with many external agencies, with its implementation of the Strengthening Communities' Program grant. In addition, the Select Committee's report to Council included commitments made by seven represented agencies including BC Housing, Northern Health, the RCMP, PGNFC, AWAC, Downtown Prince George, and the Prince George Chamber of Commerce.

It is important to continue to provide an opportunity for those agencies to update the Committee on progress and to invite other members, including those representing the Prince George Business Owners Advocacy Group, the Gateway Business Improvement Association, and the community to share information regarding their commitments to ensuring a safe, clean, and inclusive community.

A meeting of the Select Committee will be convened in early October; all members of Council are invited to attend that meeting in their ex-officio capacity. The City looks forward to the opportunity to further address issues, concerns, and opportunities for enhanced collaboration. Sincerely,

- PGNFC commits to continuing to provide shelter and outreach supports that include wellness checks, winter clothing, pain control, dental clinic services, personal storage services, and other supports specific to marginalized and vulnerable people in the community of Prince George.
- PGNFC outreach workers will work collaboratively with other outreach workers in the community (AWAC) and will continue to work closely with Bylaw Services, the RCMP, NH (Mental Health and Substance Use) to connect individuals to community services, supports and housing.

Mr. Graham Hall, Northern Health, proposed amendments regarding Northern Health's commitments to add:

 - Deliver supportive housing units.

DOWNTOWN HEALTH, SAFETY, AND CLEANLINESS INITIATIVES BOLSTERED BY NEARLY \$2 MILLION IN FUNDING

Downtown community cleanliness, safety, and health in Prince George will benefit after nearly \$2 Million in Provincial and Federal Government funding was <u>announced today</u> for the City of Prince George's Community Safety Hub.

The Community Safety Hub, which opened on April 6 on 2nd Avenue and George Street, serves as a critical connection point for many of the core agencies across governments and non-profit sectors that regularly contend with some of society's most complex issues. The establishment of the Hub was one of the key commitments approved by Council that are contained in a <u>report</u> from the Select Committee on a Safe, Clean, and Inclusive Community.

The \$1.907,593.00 in funding, which is allocated via the Union of BC Municipalities' Strengthening Communities Services Grant Program, will be used by the City of Prince George in several important ways:

- Further establishment of the Community Safety Hub (site renovations, staffing, janitorial services, and utilities)
- Increased RCMP patrols
- Security (civic facilities and parkades)
- Establishment of a Mini Transfer Station (to assist Parks and Bylaw staff to deposit and sort daily cleanups)
- Enhanced cleaning
- Service/Drop In Centre for unsheltered homeless population and comprehensive evaluation

As the City continues to implement the activities associated with this funding, the Community Safety Hub will continue to operate as a centre for downtown health and safety service coordination. The partner organizations involved with the Community Safety Hub include:

- City of Prince George (Bylaw Services)
- Northern Health
- BC Housing
- RCMP including the Downtown Safety Unit
- Prince George Native Friendship Centre
- Downtown Prince George
- Ministry of Social Development and Poverty Reduction



These organizations have come together to address a number of issues, including the health and safety of the residents of downtown encampments and enhanced cleaning protocols in the downtown area. A number of unsheltered homeless individuals have been connected with income assistance, services, and housing.

Background

Like every community, Prince George is managing complex social issues associated with two concurrent health emergencies: the ongoing opioid overdose crisis, and the COVID-19 pandemic. The response has involved multiple government ministries, Northern Health, the RCMP, the business sector, and numerous community-based organizations all working to improve the health and safety of the unsheltered homeless while addressing related community impacts.

To address persistent and multi-faceted social issues like homelessness, substance use, and mental illness, responding agencies must connect and communicate to ensure their activities are coordinated. With this goal in mind, the City of Prince George, in collaboration with its partners, launched the Community Safety Hub to enhance and support multi-jurisdictional service coordination.

While the uses for the Hub are still evolving, the location provides flexible work and meeting space for City Bylaw Services, Northern Health, BC Housing, RCMP including the Downtown Safety Unit, the Prince George Native Friendship Centre, Downtown Prince George, the Ministry of Social Development and Poverty Reduction, and more.

Notably, the Hub is not a "public facing" office and members of the public should contact participating agencies directly through their established communication channels (e.g. dialing 9-1-1 during an emergency or 3-1-1 to reach the City's Service Centre) to report a problem or request further information.
