## CITY OF PRINCE GEORGE BYLAW NO. 9241, 2021

A Bylaw of the City of Prince George to permanently close portions of road located adjacent to the properties located at 2140 Tamarack Street / 2135 Spruce Street and to remove its road dedication for the purpose of future disposal of the lands.

**WHEREAS** the Council of the City of Prince George deems it desirable that an approximate 227.50 m² (square metres) of road dedicated on Plan 8433, adjacent to the property legally described as Lot B, District Lot 777, Cariboo District; and 226.96 m² (square metres) of road dedicated on Plan 25301, adjacent to the property legally described as Lot A, District Lot 777, Cariboo District, all as shown on the Road Closure drawing attached hereto as Appendix "A", be closed to traffic, and that the road dedication thereof be removed;

**AND WHEREAS,** in accordance with section 40 of the *Community Charter,* notice of intention to adopt this Bylaw has been delivered, posted and published, and an opportunity has been provided for persons who consider they are affected by this Bylaw to make representations to Council:

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS**:

- 1. That the portion of road dedicated on Plan 8433, adjacent to the property legally described as being Lot B, District Lot 777, Cariboo District; and the portion of road dedicated on Plan 25301, adjacent from the property legally described as Lot A, District Lot 777, Cariboo District, is closed to traffic;
- 2. That the portion of road dedicated on Plan 8433, adjacent to the property legally described as being Lot B, District Lot 777, Cariboo District; and the portion of road dedicated on Plan 25301, adjacent from the property legally described as Lot A, District Lot 777, Cariboo District, is removed;
  - all as shown outlined in bold black on the Road Closure drawing attached hereto as Appendix "A" and forming part of this Bylaw.
- 3. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 4. This Bylaw shall come into full force and take effect upon its adoption and shall be filed with the Registrar of the applicable Land Title Office.
- 5. This Bylaw may be cited for all purposes as "City of Prince George Tamarack/Spruce Street Road Closure Bylaw No. 9241, 2021".
