CITY OF PRINCE GEORGE BYLAW NO. 9263, 2021

A Bylaw of the City of Prince George to amend "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004".

WHEREAS Council enacted "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004" to consolidate fees and charges from various Bylaws for numerous City services and/or uses of facilities owned or operated by the City of Prince George;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that Schedule "A", Section A – 9(b) – "Development Services: Fees and Charges for Sanitary Sewer" "Section 8: Special User Rates", subsection 8.1.2 be amended to establish fees for trucked sanitary sewer waste for the years, 2022, 2023, 2024, 2025, 2026 and 2027;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS**:

- 1. That the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended as follows:
 - 1.1. That Schedule "A", Section A 9(b) "Development Services: Fees and Charges for Sanitary Sewer", "Section 8: Special User Rates", subsection 8.1.2. be deleted in its entirety and replaced with the following:
 - "8.1.2 Volume charge* effective January 1, 2022
 - *for sites without flow meters, truck capacity must be provided and billing will be based off 90% of total capacity for each unit."
