Dear Mayor Hall and Council:

I am pleased to advise you that the Province is in the process of issuing your municipality's 2021 Grant-in-Lieu of property tax payment by electronic funds transfer. These funds are planned to be transferred to you around November 10, 2021.

Based on the property identified in the attached Grant Payment Details Report, your payment for 2021 is \$2,365,315.53. This payment is for provincially owned properties in your community and is made in accordance with the *Municipal Aid Act*. If your payment has changed from last year, it is likely due to a revised valuation by the BC Assessment Authority, a change in the property tax rates, or through changes in responsibility for real property.

Included in this payment is \$140,090.45, due to your Regional District. This amount is to be transferred to them at your earliest convenience.
