## CITY OF PRINCE GEORGE BYLAW NO. 9262, 2021

A Bylaw of the City of Prince George to rezone certain lands and to amend "City of Prince George Zoning Bylaw No. 7850, 2007".

**WHEREAS** pursuant to the provisions of Section 479 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that "Retail, Cannabis" be added as a secondary use to the Z1: Airport zone only on the subject property, to facilitate a retail cannabis store, or other uses pursuant to the Z1: Airport zoning designation(s);

- 1. That "City of Prince George Zoning Bylaw No. 7850, 2007", be amended as follows:
  - a. That Section 15.1.3 "Z1: Airport": "Secondary Uses" be amended by inserting the words "Retail, Cannabis only on Lot A, District Lots 626, 627, 629, 630 and 631 Cariboo District, Plan EPP49265".
- 2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
- That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 4. That this Bylaw may be cited for all purposes as "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9262, 2021".
