## Applicant:

Ms. Ashley Thandi, Planner, and Ms. Megan Hickey, Planner, L&M Engineering Ltd., attended Centre Table and provided a PowerPoint presentation in support of the application including information on the underlying zoning of the subject property, proposed subdivision development of ten (10) lots, identification of no-build areas and a five (5) metre riparian buffer strip on the proposed lots, and public consultation conducted with the neighbouring properties.

Discussion commenced. Ms. Thandi and D. Wasnik, Director of Planning and Development, responded to questions of Council.

## Members of the Public:

Mr. Brett Johnson, 8215 Corral Road, attended Centre Table and spoke in opposition to the application noting concerns regarding potential impacts of the proposed development on the capacity of the Western Acres Lagoon, recently upgraded Western Acres well and riparian area and further noted concerns regarding the likely increase of elementary school traffic and inquired on the City's plans for connection of the

Western Acres properties to the Lansdown Wastewater Treatment Plant and plans to address fire hydrant access and water flow.

Discussion commenced and B. McIntosh, Director of Civic Operations, responded to questions of Council noting that the extension of the connection to the Lansdowne Wastewater Treatment Plan was approved as a 2022 capital project and the request for proposal was recently awarded. A detailed design and build is expected to occur over the coming year.

Mr. Trent Blair, 10271 Western Road, attended Centre table and spoke in opposition to the application noting concerns regarding the reduced setbacks from the riparian area and for accommodation of the culvert between lots one and two and seven and eight and noted further concerns regarding the lack of fire flow and hydrants in Western Acres and inquired on the capacity of the new Western Acres well accommodating additional development.
