## CITY OF PRINCE GEORGE BYLAW NO. 8984, 2019

A Bylaw of the City of Prince George to rezone certain lands and to amend "City of Prince George Zoning Bylaw No. 7850, 2007".

**WHEREAS** pursuant to the provisions of Section 479 of *the Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that a certain property be rezoned from P2: Minor Institutional to C7: Transitional Commercial to facilitate an office use for Staffing Solutions that focuses on the education and placement of healthcare professionals across the Province, or other uses, pursuant to the C7: Transitional Commercial zoning designation(s);


