WHEREAS the Municipality, pursuant to Section 702 A of the Municipal Act, may, notwithstanding and By-Law of the Municipality, or Section 712 or 713 of the Municipal Act, enter into a Land Use Contract containing such terms and conditions for the use and development of land as may be agreed upon with a developer, and thereafter the use and development of the land shall be in accordance with the Land Use Contract;

AND WHEREAS the Developer has presented to the Municipality a scheme of use and development of the within described lands and premises that would be in contravention of a By-Law of the Municipality or Section 712 or 713 of the Municipal Act or both, and has requested that the Council of the Municipality enter into this contract under the Municipal Act or both, and has requested that the Council of the Municipality enter into this contract under the terms, conditions and for the consideration hereinafter set forth;

AND WHEREAS the Council of the Municipality, having given due consideration to the criteria set forth in Sections 702 (2) and 702 A (1) of the Municipal Act, have agreed to the terms, conditions and consideration herein contained;

AND WHEREAS the Municipality and the Developer both acknowledge that the Council of the Municipality could not enter into this Agreement, until the Council held a Public Hearing in relation to this Agreement, and considered any opinions expressed at such Hearing, and unless a majority of all the members of the Council voted in favour of a By-Law to authorize the Municipality to enter into this Contract;

NOW THEREFORE this Agreement witnesseth that in consideration of the premises and the conditions and covenants hereinafter set forth, the Municipality and the Developer covenant and agree as follows:

Owner

The Developer is the registered owner of an estate in fee simple of all and singular that certain parcel or tract of land and premises, situate, lying and being in the City of Prince George, in the Province of British Columbia, and being more particularly known and described as:

Land

Lot 4, District Lot 633, Plan 9298

(hereinafter called the "Land")

Consents

The Developer has obtained the consent of all persons having a registered interest in the land as set out in the schedule prefacing the consents to the use and development set forth herein which consents are attached hereto.

Uses

The land, including the surface of water, and any and all buildings and structures erected thereon, thereover or therein shall be used for the purpose specified in Schedule "A" hereto and for none other and shall comply with the special siting provisions set out therein.

Subdivision

4. The area, shape and dimensions of all parcels created by the subdivision of the land including the dimensions, location and alignment of all highways created shall conform to the plans set out in Schedule "G" hereto.

Excessive Costs

Security and 5. The Developer shall pay to the Municipality the excessive cost fees set out in Schedule "K" hereto.

By-Law Compliance

Except as herein specifically provided, the provisions of the Municipal Act and the By-Laws of the Municipality apply to the land herein described.

Registration

6. This Agreement shall be construed as running with the land and shall be registered in the Land Registry Office by the Municipality pursuant to the provisions of Section 702 A (4) of the Municipal Act.

Interpretation

7. Whenever the singular or masculine is used herein, the same shall be construed as meaning the plural, feminine or body corporate or politic where the context or the parties so require.

Binding

8. This Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective heirs, executors, administrators, successors and assigns.

# CITY OF PRINCE GEORGE

## BY-LAW NO. 3074

A By-Law of the City of Prince George to authorize the issuance of a Land Use Contract.

WHEREAS pursuant to the provisions of Section 702 A of the Municipal Act the Council may by By-Law enter into a Land Use Contract for the use and development of land;

AND WHEREAS such By-Law shall not be adopted by a Council until a Public Hearing has been held and then only upon the affirmative vote of two thirds of all the members of Council present and eligible to vote;

AND WHEREAS the Council has by By-Law designated areas of land as development areas as required under Section 702 A (2) of the Municipal Act;

AND WHEREAS a Public Hearing was held in accordance with the Municipal Act and notice has been given according to By-Law.

NOW THEREFORE the Council of the City of Prince George in open meeting assembled, enacts as follows:

- 1. The Mayor and Clerk are hereby authorized to execute on behalf of the Municipality a Land Use Contract with respect to Lot 4, District Lot 633, Plan 9298 to permit subdivision of less than 2 acres. Location: Blackburn Road. Applicant: Robert and Beryl Walters.
- 2. The Contract entered into shall be registered in the Land Registry Office, Prince George.
- 3. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this  $\ensuremath{\mathtt{By-Law}}$  .
- 4. This By-Law may be cited for all purposes as "Authorization Issuance Land Use Contract No. LU 37-77, By-Law No. 3074, 1977".
