

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 9313, 2022**

**A Bylaw of the City of Prince George to amend “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”.**

**WHEREAS** Council enacted “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004” to consolidate fees and charges from various Bylaws for numerous City services and/or uses of facilities owned or operated by the City of Prince George;

**AND WHEREAS** Council has deemed it desirable that “Schedule “B”, Section B-5: Community Services - Fees and Charges for the Pine Valley Golf Centre” of the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004” be amended to reflect the new categories and fees attached hereto as Appendix “A” and forming part of this Bylaw.

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled,  
**ENACTS AS FOLLOWS:**

1. That the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004” be amended as follows:
  - 1.1 That Schedule “B”, “Section B-5: Community Services - Fees and Charges for the Pine Valley Golf Centre” be removed in its entirety and replaced with a new Schedule “B”, “Section B-5: Community Services - Fees and Charges for the Pine Valley Golf Centre” in the form attached to and forming part of this Bylaw as Appendix “A”.
2. This Bylaw may be cited for all purposes as “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 9313, 2022”.
