SUBJECT: 2020 Permissive Tax Exemptions

ATTACHMENT(S): Recommended 2020 Permissive Tax Exemptions

RECOMMENDATION(S):

That the Standing Committee on Finance and Audit recommend that Council approve the 2020 Permissive Tax Exemptions itemized in the attachment to the report dated September 3, 2019 from the Director of Finance titled "2020 Permissive Tax Exemptions".

PURPOSE:

The report provides the Standing Committee on Finance and Audit with an itemized list of the applications that meet the criteria for 2020 Permissive Tax Exemptions and requests that the Committee recommend that Council approve the exemptions.

STRATEGIC PRIORITIES:

Sustainable Finance Guideline 5.5 indicates that Permissive Tax Exemptions are a means for Council to support organizations within the community to further Council's objectives of enhancing quality of life and delivering services economically. There is no obligation on Council's part to grant exemptions.

POLICY/REGULATORY ANALYSIS:

Council approves Permissive Tax Exemptions in accordance with the authority granted through Section 224 of the *Community Charter*.

The Permissive Tax Exemption Policy was used in conjunction with the Permissive Tax Exemption Administrative Procedure to adjudicate the Permissive Tax Exemptions. As per the Policy, the length of the exemptions provided will be granted to the organizations for a period that coincides with the existing Council's term of office, up to a maximum of 4 years. However, the owners of the exempted properties are expected to apply annually and state any changes that have occurred, which are then reviewed by Administration.

FINANCIAL CONSIDERATIONS:

Permissive Tax Exemptions are generally granted for non-profit organizations, places of public worship, and municipal tenants. The total estimated value for the tax exemptions in this report's recommendations is \$1,900,575 or 1.73% of the tax levy (based on 2019 tax rates and assessment

values). The exact amount of these exemptions will not be known until the time that BC Assessment releases the revised property tax roll in 2020.

Non-Profit Organizations

The estimated value of exemptions recommended for non-profit organizations for 2020 is \$1,084,749; the value of new exemptions recommended by Administration is \$52,506. The new non-profit applications are:

1. 00-02798-000 – Association Advocating for Women and Children (AWAC) – 28 low income units for individuals struggling with homelessness due to addictions, mental health and health issues with 24 hour staff to provide assistance and life skills support to the tenants.
2. 00-00891-000 – Canadian Mental Health – This building is leased from an owner who is not otherwise exempt from taxation under s. 220 of the *Community Charter* and therefore does not meet the subject property guideline to qualify for an exemption.
3. 00-21297-612 – AiMHi - Prince George Association for Community Living – Residence for the care of people with developmental disabilities who are unable to care for themselves. AiMHi sold a previously exempt property on McDonald St and has purchased this one in its place.
4. 00-26652-000 – Carrier Sekani Family Services – Providing one-on-one family support, parenting education and outreach to families with children 6 years old and under. Programs are prevention based and offered in a supportive and structured environment. Learning is facilitated in many areas such as: parenting support, life skills, communication and anger/stress services are provided in a holistic manner, focusing on the family as a whole but also on individual needs.
5. 00-06910-000 – Aboriginal Housing Society – As of the date of this report, Administration is waiting for a call to confirm the uses of the land and building meet the requirements for exemption. The application is included in the attachment of approved properties. Assuming the applicant can confirm the use of land and building, this property will also be included in the list on the report that goes to Council.

Administration recommends that the AWAC, AiMHi, Carrier Sekani Family Services, and Aboriginal Housing Society applications be APPROVED.

Administration recommends that the Canadian Mental Health applications be DENIED as they do not meet the requirements for exemption at the time of this report.

Places of Public Worship

Places of Public Worship generally receive statutory tax exemptions. The Permissive Exemption they apply for relates to the hall and the land surrounding the school or place of worship. The estimated value of exemptions for places of worship for 2020 is \$273,240. This section used to include Private Schools but legislation was changed in 2017 and they are now entitled to the same statutory exemption as Public Schools, and no longer required to apply for permissive tax exemptions. This change has decreased the amount of permissive tax exemptions granted by the City to public schools by \$234,804 and decreased the value of exemptions as a percentage of the total tax levy by 0.22%.

New applications for places of public worship:

1. 00-21672-100 – The Well – A Gathering Place – This is the old Kingdom Hall of the Jehovah's Witness. They have subdivided the property and built a new Jehovah's Witness church. The Well operates out of the old church and the land and buildings are used as place of worship, church services and related activities. Application has been made to include *The King's In Bible Store* on this property. The area used for the Bible Store will not be exempt and the applicant is aware of this.

Administration recommends that The Well – A Gathering Place application be APPROVED.

Municipal Tenants

Municipal Tenants who meet the criteria of the Permissive Tax Exemption program can apply if the property taxes are not already a financial consideration as part of their lease agreement. The estimated value of the exemptions recommended for municipal tenants in 2020 is \$542,585. There is no change in the recommended list of properties for exemption from 2019.

As in prior years, BC Assessment will assess City tenants for commercial areas and those areas will be taxable. The taxable portion, which is unknown at this time, is not reflected in this report. Therefore, the estimated tax assistance for City tenants may be slightly overstated.

There are no new applications for exemption from municipal tenants.

SUMMARY AND CONCLUSION:


The recommended permissive exemption amount for 2020 (\$1,900,575) does not include statutory exemptions provided under Section 220 of the *Community Charter*.
