## CITY OF PRINCE GEORGE BYLAW NO. 9285, 2022

A Bylaw of the City of Prince George to rezone certain lands and to amend "City of Prince George Zoning Bylaw No. 7850, 2007".

**WHEREAS** pursuant to the provisions of Section 479 of *the Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that the subject property be rezoned from RT1: Two-Unit Residential to RT2: Two-Unit Residential, to facilitate the development of a two-unit house (duplex) on the subject property, or other uses, pursuant to the RT2: Two-Unit Residential zoning designation;
