## CITY OF PRINCE GEORGE BYLAW NO. 9333, 2022

A Bylaw of the City of Prince George to rezone certain lands and to amend "City of Prince George Zoning Bylaw No. 7850, 2007".

**WHEREAS** pursuant to the provisions of Section 479 of *the Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that the subject property be rezoned from RS2: Single Residential to C8: Commercial Conversion, to facilitate a Health Service, Minor use (medical office) on the subject property, or other uses, pursuant to the C8: Commercial Conversion zoning designation;

  - a. That Lot 5, Lot 6 and the West ½ of Lot 7, Block 155, District Lot 343, Cariboo District, Plan 1268, be rezoned from RS2: Single Residential to C8: Commercial Conversion, as shown on Appendix "A", attached to and forming part of this Bylaw.
- 2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
- 3. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 4. That this Bylaw may be cited for all purposes as "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9333, 2022".
