The Terms of Reference for the Standing Committee on Intergovernmental Affairs has been amended to reflect the Committee's new name and clarifications on the Committee's purpose and mandate. At their first meeting, each Committee will elect one of its members as Committee Chair.

The City of Prince George's Council Procedures Bylaw states that all members of Council not appointed to a standing committee are ex officio members of that standing committee. Ex officio members of a standing committee may not make motions and do not have voting rights but may participate in the discussion at committee meetings.
