That Council APPROVES the designation of Councillors as Acting Mayor from November 2022 to October 2026, as set out on the Acting Mayor Schedule: 2022 to 2026 attached to the report dated October 25, 2022, from the Corporate Officer/Manager of Legislative Services, titled "Appointment of Acting Mayors for the 2022 to 2026 Council Term."

B.4 Appointment of Municipal Directors to the Regional District of Fraser-Fort George Board

Moved By Councillor Frizzell Seconded By Councillor Skakun

That Council APPOINTS Mayor Yu to serve as a Municipal Director on the Regional District of Fraser- Fort George Board until the first meeting of Council is held after the 2026 General Local Election, and ASSIGNS a voting strength of five (5) votes to that Director position.

Carried Unanimously

Discussion commenced and M. Connelly, Corporate Officer/Manager of Legislative Services, responded to questions of Council.

The following Councillors were nominated to serve as a Municipal Director on the Regional District of Fraser-Fort George Board: Councillor Klassen, Councillor Ramsay, Councillor Sampson, Councillor Scott, and Councillor Skakun.

Council voted by ballot, once for the determination of the three remaining Municipal Director positions and once for the determination of the Floating Primary Alternate Municipal Director position. M. Connelly, Corporate Officer/Manager of Legislative Services, announced the results of the Council Members receiving a majority vote.

Moved By Councillor Scott Seconded By Councillor Bennett

That Council APPOINTS Councillor Ramsay, Councillor Sampson, and Councillor Skakun to serve as Municipal Directors on the Regional District of Fraser-Fort George Board until the first meeting of Council is held after the 2026 General Local Election, and ASSIGNS a voting strength of five (5) votes to each of those three (3) Municipal Director positions.

Moved By Councillor Sampson Seconded By Councillor Bennett

That Council APPOINTS Councillor Scott to serve as the Floating Primary Alternate Municipal Director on the Regional District of Fraser-Fort George Board until the first meeting of Council is held after the 2026 General Local Election.

Moved By Councillor Scott Seconded By Councillor Sampson

That Council APPOINTS Councillor Bennett, Councillor Frizzell, Councillor Klassen, and Councillor Polillo, in rotating alphabetical order, to each serve as a Secondary Alternate Municipal Director to each of the four (4) Municipal Directors on the Regional District of Fraser-Fort George Board until the inaugural meeting of Council is held after the 2026 General Local Election.
