CITY OF PRINCE GEORGE BYLAW NO. 9359, 2022

A Bylaw of the City of Prince George to rezone certain lands and to amend certain text within "City of Prince George Zoning Bylaw No. 7850, 2007".

WHEREAS pursuant to the provisions of Section 479 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

- 1. That "City of Prince George Zoning Bylaw No. 7850, 2007", be amended as follows:
 - a. that Section 11.6.2 "C6, C6c, C6l: Highway Commercial": "Principal Uses" be amended by inserting the words "Liquor Primary Establishment, Minor only on Lot A, District Lot 1432, Cariboo District, Plan 26796".
- 2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
- That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- That this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9359, 2022".
