C. REPORTS

C.1 Police Services Review

A. Davey, Director of Public Safety, and Superintendent Wright, RCMP, provided an overview of the report.

Dr. Curt Taylor Griffiths, Ph.D., Simon Fraser University, and Dr. Joshua J. Murphy, Ph.D., Kwantlen Polytechnic University, provided a PowerPoint presentation regarding the police resource review of the Prince George RCMP detachment including information on the project framework and method, information regarding the municipality including quality of life, residents, community policing, the local RCMP detachment, calls for services, at-risk and vulnerable persons, and recommendations pertaining to policing framework and strategy, and RCMP member and municipal staffing strength.

Discussion commenced regarding triaging incoming calls at dispatch, strategies to reduce the number of calls to the RCMP that are not of a policing nature, implementing a community safety and well-being plan as a means of building crime prevention capacity, and staffing enhancement requests for an increase in the number of RCMP members and municipal employees supporting police services.

A. Davey, Director of Public Safety, Superintendent Wright, Dr. Griffiths, and Dr. Murphy responded to questions of Council.
