Prior to my main comments I must state that I am totally in support of increasing the range of senior housing in Prince George. We need housing for seniors and we need a variety from apartments to condos to single home ranchers. We need the range of senior housing in acceptable locations. The developer should have been more thorough in the presentation of the proposal. Look for alternative locations to be offered to the developer where they can provide a facility more in keeping with the vision outlined in some of their promotional documents.
