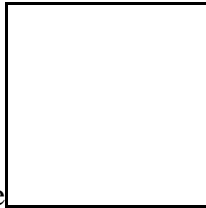

Good afternoon, Mayor Hall, members of Council and Ms. Soltis:

With respect to the media release distributed on Wednesday November 27, 2019, outlining the 'Public Consultation on Social Issues', to be held in Council Chambers during the Regular Council meeting of December 2, 2019, please accept this letter as the undersigned's official response.

Social issues such as mental health and addiction are serious societal problems, and Prince George is certainly not alone in working to support those affected, while also striving to create improved social outcomes. The negative social outcomes from these systemic problems affect many aspects of a community, including but not limited to, the business community that supports and sustains a thriving community. Through our consultations, we heard consistently that business owners and operators did not feel engaged, listened to and incorporated into the discussion on social issues. As a result, we have committed to taking a leadership role, acting as an advocate for the business owners, operators and their teams – providing sound policy recommendations to all levels of government. We recognize that all three levels of government must be engaged to find solutions to these issues, and it is not solely one party's responsibility.

Given the above, we have previously submitted a request to appear as a delegation to Council at the December 16, 2019 Regular Council Meeting in the City of Prince.

The Prince George Chamber hosted a Community Business Consultation Meeting on November 12, 2019 with participation from Downtown PG, and the Gateway BIA – organizations which jointly represent and advocate on behalf of more than 1,200 businesses and property owners. At that meeting, we committed to our members that we would take their feedback, develop specific policy recommendations, and bring them back to the aforementioned membership group for further feedback. We committed to doing this in a transparent manner, with their involvement, and their specific views considered. Within these recommendations, our organizations are developing specific policy and budgetary recommendations to be considered for City of Prince George's 2020 budgetary cycle. Given that our organizations were given three business days notice of Council's December 2<sup>nd</sup> meeting, the timeframe does not allow our



organizations time to re-engage those impacted to discuss our proposed policy recommendations, and make any necessary amendments as we had committed to do. We plan to adhere to our commitment to proper consultation with our members, and any businesses who would like to participate, and will be meeting with them on or before December 11<sup>th</sup>.

While we plan to attend the 'Public Consultations on Social Issues' next week to hear any new information not gleaned during our business engagement, we are not, however, in a position to participate as a presenter. We would respectfully request that the City accept our request to present as a joint delegation at the December 16<sup>th</sup> Regular Council meeting to present our policy and budgetary recommendations that incorporate the important feedback from the Prince George business community.

Thank you in advance for the request to present on December 2, 2019. We look forward to engaging further and collaborating on solutions that improve our great community of Prince George.

Thank you for the opportunity to address potential solutions to making down town a safer and inviting place for all residents. Here are some thoughts on actionable solutions that are both short and medium term.

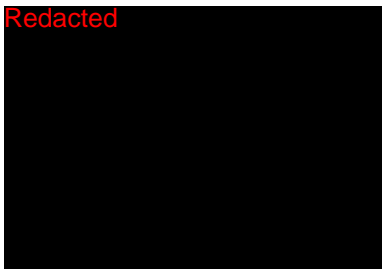
- 1) Have social agencies with offices or who are performing activities in the down town core sign and commit to a good neighbor agreement. This is to encourage them and their staff to keep their properties and the surrounding area clean, free from loitering, free from illegal activities, and garbage that is the product of their service role. If they are handing out disposable products they should be responsible for cleaning it up.
- 2) Enforce accountability. Agencies that assist poverty, support and enable harmful activities via harm reduction services should be contributing to the clean up of the mess that is created by the materials and food they distribute. This should NOT be the city and tax paying business owners burden to bare. Fine and removal of permit to operate for non compliance.
- 3) Utilize affordable solar and led lighting solutions (for example carmanah technologies from Victoria [www.solarlighting.com](http://www.solarlighting.com)) to increase light on 5-7<sup>th</sup> in alleys and in city owned parking lots. This type of lighting can fit within current infrastructure is proven and can be easily removed if and when needed.
- 4) Private security patrols of the down town core split shifts 6 am – 10 am and 4 pm-8pm to provide visible street presence, deter loitering, panhandling and illegal activities during business hours. Could easily be done with 2 patrols on foot or scooter/bikes ect but no cars.
- 5) Provide seed funding or assist in finding seed funding for social enterprise that provides skills training, employment and community engagement for down town community. ( this is not more counselling, group therapy or enabling activities but actual work or jobs that have value and increase self-confidence)
- 6) Work with agencies to create day use facilities where individuals can gather , socialize, rest, continue to smoke, use drugs ect that is off the streets, supervised and has no impact on surrounding businesses via footprint or curb appeal
- 7) Stop providing property tax rebate or grants to nonprofits and social agencies in the down town core. Prevent further social agencies and nonprofits from buying property in the down town core. Do so via zoning or other tools at cities disposal. Clustering of this type of tenants or owners does not increase residential traffic, creates “safe zones” for loitering and illegal activities and disrupting traffic patterns that are not retail or business centric.
- 8) Work with property owners, business owners and employees to properly prosecute theft and violence, increase safety of staff, as well as incentivize new business to locate down town via co-op incentives such as marketing, lease holds, property tax reductions, support services, training, first buyer programs.
- 9) Work with or delegate to third party economic development agencies rather than competing or duplicating efforts that organizations like Community Future and HubSpace, Chamber, Downtown PG, NDIT are providing.

The goal of creating diversified business clusters in the down town. Build on the nice restaurant cluster now established by working with experienced ec dev organizations.

- 10) Become more business friendly internally, easier to start a business and maintain it via bylaws, development permits, parking and rezoning applications in the down town core. As an example it is hypocritical that a rezoning to become a legal dispensary has been difficult and in some cases blocked, yet a needle exchange, safe injection site and testing site of illegal substances which contributes to down town problems is allowed and in fact expanded even with large amounts of public outcry.


