We hope and trust that you are well.

As you will recall, last year the IURC Homelessness Initiative submitted a funding application to the national Social Sciences and Humanities Research Council (SSHRC). The application was for a 7-year \$2.5 million project working in Prince George, Kamloops, and Kelowna. The application writing was led by one of the IURC partners (Dr. John Graham from UBC-Okanagan). At the time, the City provided a very good letter of support – the letter was signed by Walter and the letter process was managed by Chris Bone. As the first stage of a two-stage application process, our application last year came immediately below the funding cut-off line.

With very supportive comments from the funding agency (which included helpful suggestions for improving the application), the process of preparing a new application for this year's intake is now underway. We are writing as we are again seeking for letters of support from our partners. We are also reaching out to the FNHA, NHA, and CSFS.

As was the case last year, the application involves a national team of diverse researchers. It will again be led by Dr. John Graham, and the focus will continue to be on preventing homelessness through community-embedded research with a positive social impact focusing on small to medium sized cities (a copy of past year's application is attached as information).

The application is for a seven-year SSHRC Partnership Grant. As last year, we are requesting the City to join us as an Invited Partner on the application. The City's letter from last year was very good. SSHRC's comments on the collective body of support letters was to think a bit more about individualizing the letters – thinking about anything from the intervening year that might show what the organization hopes to gain from the partnership, what they might be able to bring to the partnership, and any events of changes that can highlight how this research will assist their own decision making and future operations.

We are attaching a copy of your letter of support from last year. Ideally, we are hoping this letter could be placed on your letterhead and provided back to us by December 15<sup>th</sup>, 2022. A member of our team will be available to provide direction and support in the process of uploading the letter to the SSHRC Application Portal in January 2024. We would be truly grateful for your support again with this upcoming grant; it will greatly assist in the significant reduction of homelessness in our community.
