CITY OF PRINCE GEORGE BYLAW NO. 9481, 2024

A Bylaw of the City of Prince George to amend certain text of "City of Prince George Freedom of Information and Protection of Privacy Bylaw No. 8689, 2015."

WHEREAS pursuant to the *Freedom of Information and Protection of Privacy Act*, RSBC 1996, c. 165, as amended, Section 77 requires that Council designate a person or group of persons as the "head" for the purposes of the Act. Section 66 of the Act authorizes the "head" to delegate to any person any duty, power or function of the head;

AND WHEREAS "City of Prince George Freedom of Information and Protection of Privacy Bylaw No. 8689, 2015" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that certain text be amended, added, removed, and replaced to provide consistency and clarity to the interpretation of the Freedom of Information and Protection of Privacy Bylaw;

NOW, THEREFORE, the Council of the City of Prince George, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. That "City of Prince George Freedom of Information and Protection of Privacy Bylaw No. 8689, 2015", be amended as follows:
 - a. That Section 2.1 be amended by deleting the words "City Manager" and replacing them with "Manager of Legislative Services (Corporate Officer)."
 - b. That Section 2.2 be deleted in its entirety and replaced with the following:
 - "2.2 The Supervisor of Information and Privacy be designated a Coordinator of the City for the purposes of the Act."
 - c. That a new Section 2.3 be added immediately following Section 2.2:
 - "2.3 For the purposes of the Act, the Head and the Coordinator shall act in their respective capacities for Council, Boards, Commissions, and Committees established by the City."
- 2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 3. That this Bylaw may be cited for all purposes as the "City of Prince George Freedom of Information and Protection of Privacy Bylaw No. 8689, 2015, Amendment Bylaw No. 9481, 2024."
