

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 9472, 2024**

A Bylaw of the City of Prince George to amend the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”.

**WHEREAS** Council enacted “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004” to consolidate fees and charges from various Bylaws for numerous City services and/or uses of facilities owned or operated by the City of Prince George;

**AND WHEREAS** Council deems it desirable to amend the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, for the purposes of establishing fees and charges for the calendar years 2025, 2026, and 2027, by amending Schedule “B”, Section “B-2(m): Prince George CN Centre Suite Fees and Schedule” and Schedule “A”, Section “A-3: Cemetery Fees;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, be amended as follows:
  - a) That Schedule “A”, Section “A-3(b): Cemetery Fees – Grave Covers” be deleted in its entirety and replaced with a new Schedule “A”, Section “A-3(b): Cemetery Fees – Grave Covers” as attached to and forming part of this Bylaw as Appendix “A”;
  - b) That Schedule “B”, Section “B-2(m): Prince George CN Centre Suite Fees and Schedule” be deleted in its entirety and replaced with a new Schedule “B”, Section “B-2(m): Prince George CN Centre Suite Fees and Schedule” as attached to and forming part of this Bylaw as Appendix “B”.
2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
3. That this Bylaw may be cited for all purposes as the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 9472, 2024”.
