### CITY OF PRINCE GEORGE BYLAW NO. 9485, 2024

A Bylaw of the City of Prince George to amend the "City of Prince George Officer Positions and Delegation of Authority Bylaw No. 8340, 2011".

**WHEREAS** Council enacted "City of Prince George Officer Positions and Delegation of Authority Bylaw No. 8340, 2011" to delegate certain powers, duties and functions of Council, to an Officer or the employee of the City;

**AND WHEREAS** Council deems it desirable that certain text be amended, added, removed, and replaced to provide consistency and clarity to the interpretation of the Officer Positions and Delegation of Authority Bylaw;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:** 

- 1. That "City of Prince George Officer Positions and Delegation of Authority Bylaw No. 8340, 2011", be amended as follows:
  - a. that Section 2(e) in Section 2 "Definitions" be deleted in its entirety and replaced with
    - "(e) "Director of Finance and IT Services" means the officer position of the City Financial Officer";
  - b. that Section 2 "Definitions" be amended by adding the following definition and renumbering subsequent sections accordingly
    - "(b) "Chief of Police" means the appointed officer in charge of the Prince George City detachment of the Royal Canadian Mounted Police, or their designate";
  - c. that in Section 3.1.1(c), the words "Director of Finance" be replaced with the words "Director of Finance and IT Services";
  - d. that in Section 3.1.3, the words "Director if Finance" be replaced with the words "Director of Finance and IT Services";
  - e. that in Section 3.2.3, the words "Director of Finance" be replaced with the words "Director of Finance and IT Services";
  - f. that in Section 3.2.3.1, the words "Director of Finance" be replaced with the words "Director of Finance and IT Services";
  - g. that in Section 4.3 (c), the words "Corporate Services" be replaced with the words "Administrative Services";
  - h. that in section 4.3 (e), the words "Director of Finance" be replaced with the words "Director of Finance and IT Services";

- i. that in section 4.3 (f), the words "Recreation and Events" be replaced with the words "Civic Facilities and Events";
- j. that section 4.3 (h) be deleted in its entirety and the subsequent section be renumbered to immediately follow section 4.3 (g);
- k. that in section 4.5, the words "his/her" be replaced with the word "their";
- I. that in section 7.4, the words "Community Services" be replaced with the words "Civic Facilities and Events";
- m. that "Schedule A" be deleted in its entirety and replaced with new "Schedule A", attached to, and forming part of this Bylaw as Appendix "A";
- n. that "Schedule B" be deleted in its entirety and replaced with new "Schedule B", attached to, and forming part of this Bylaw as Appendix "B"; and
- o. that "Schedule C" be deleted in its entirety and replaced with new "Schedule C", attached to, and forming part of this Bylaw as Appendix "C".
- 2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 3. That this Bylaw may be cited for all purposes as the "City of Prince George Officer Positions and Delegation of Authority Bylaw No. 8340, 2011, Amendment Bylaw No. 9485, 2024".
