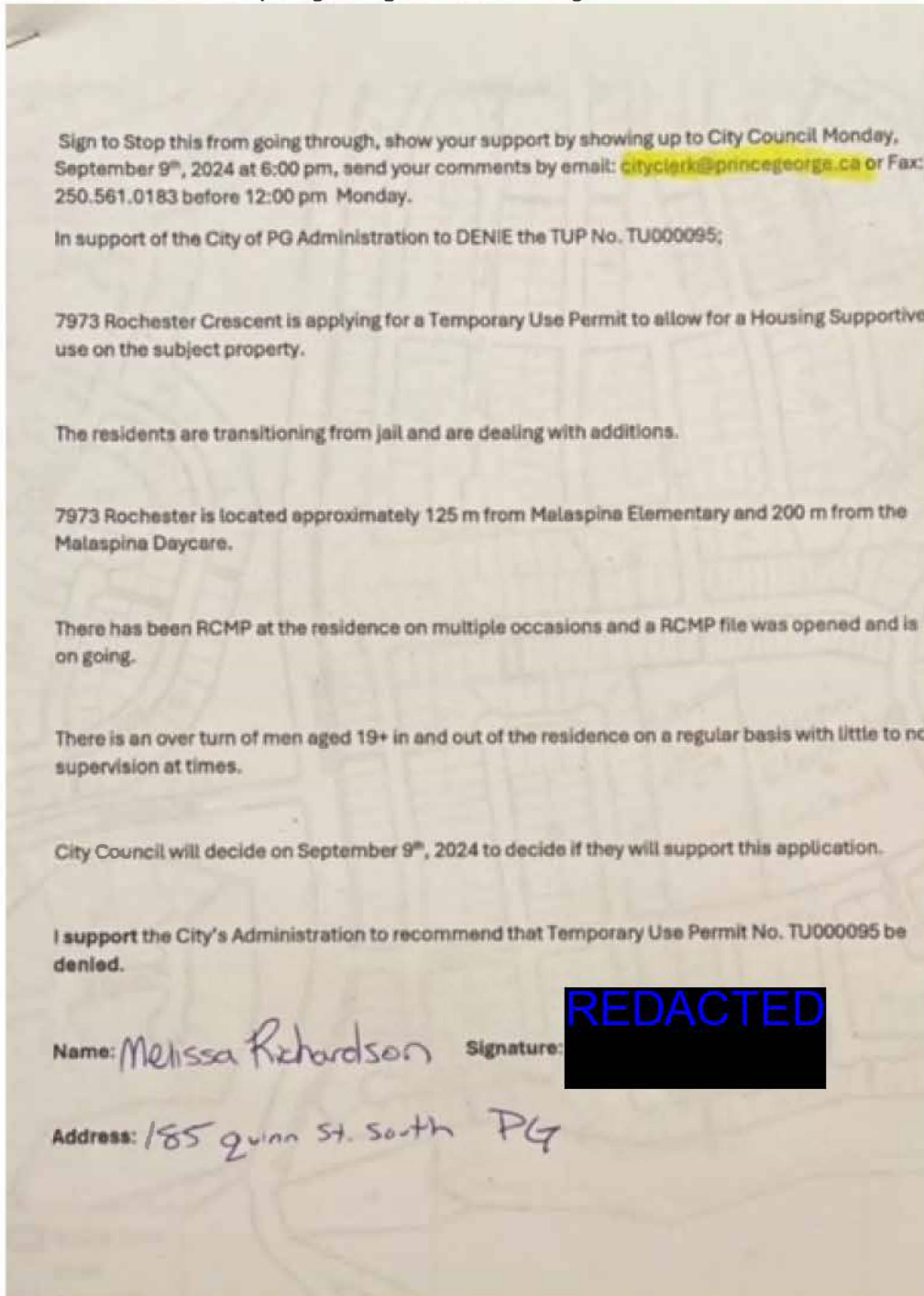

Good day City of Prince George staff. My name is Eric Charest, my wife is Karen Schneider, and we reside at 7994 Rochester Crescent for just over five years. We would like our email to stand in support of this application.

We were made aware of the application yesterday when an unsigned letter was hand delivered to our mailbox asking us to oppose the permit. The letter contains information that, we feel, misrepresents the nature of the request, and we would like city council to take into account the perspectives of neighbors who have no issue with this application.

From a quick internet search, the company making the permit request appears to have been at this address already for many years. During this time, they have been ordinary, inobtrusive neighbours. The letter delivered to us appears to fear monger, referencing a police incident at that location. We were witnesses to this one lights-and-sirens event, which inconvenienced us a total of a ten minute wait while the road was closed during an arrest with no violence or altercation. This event could have happened anywhere and is in no way indicative of an ongoing police issue at this property.

Police vehicles periodically stop by the house, but not in an emergency fashion.

In our five years, the residents of 7973 Rochester have mostly kept to themselves, been polite, and kept the yard clean. They have not impacted our community negatively in any way that we have observed. During the times when the residents left the property, there has always appeared to be an identifiable staff member escorting the group.

We have been aware that this house was used for some type of transitional housing since we moved in. Our comments are based on the belief that the nature of the usage of the house will remain consistent with how it has been used over the past few years, and this temporary use permit is not a meaningful change from previously. What little online information we could find about this type of temporary use permit seemed to support this belief.

Please accept our comments as support for this application at this time.

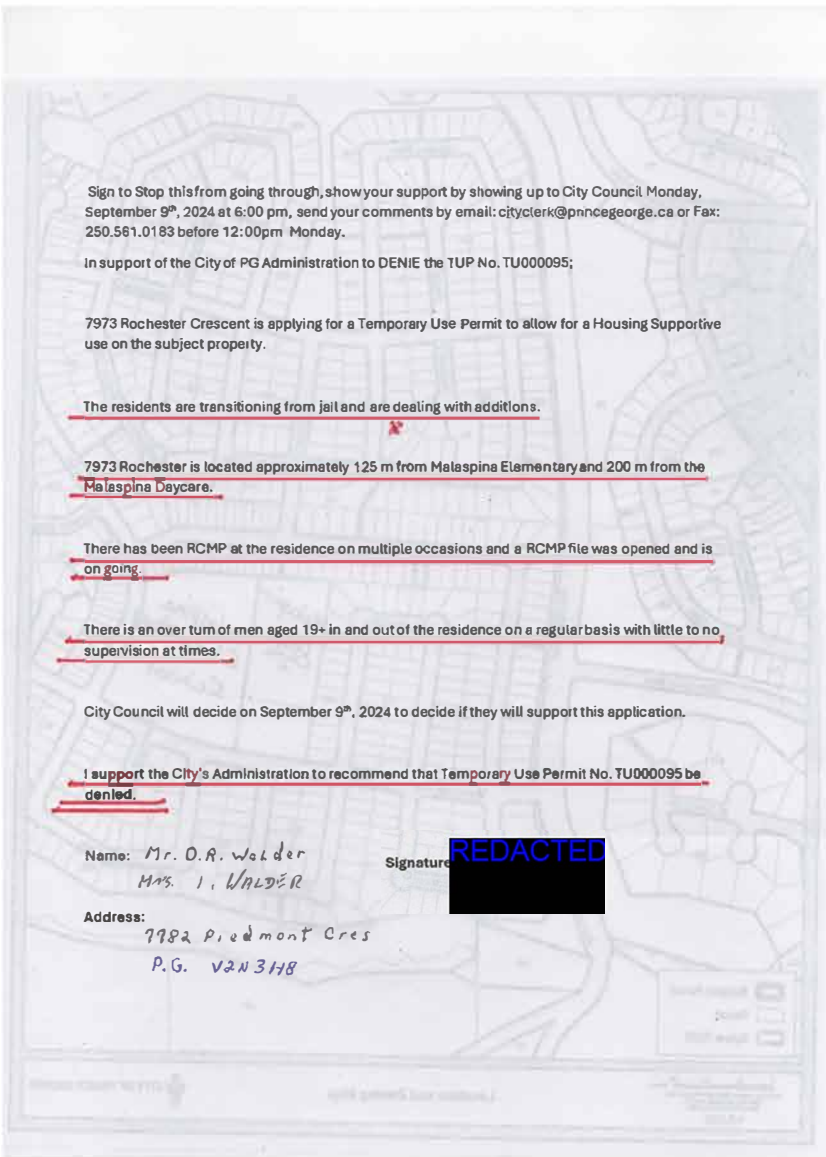

On August 24, 2023, the Integrity Recovery Society began the process of acquiring a TUP for recovery services for the above noted address. After several months of working with an officer in the planning department, I was informed that administration is struggling to support our application and that it will be forwarded to council along with a recommendation to deny.

To the application,

It is my hope that council has succeeded in finding the information needed to support the application for TUP 000095. Speaking with residents in the area, I was informed they will be speaking positively on our behalf voicing their support, along with letters of support provided to council.

The Integrity Recovery Society has been at this location for over 4 years now. There have been no assaults, no break ins, no calls of suspicious activities, partying or drug use. There have been no negative impacts from our presence nor has the property value plummeted since our arrival. I do believe it is safe to say that over the 4 years we have demonstrated not only can we co-exist in College Heights but are wanted and welcomed by our surrounding neighbors.

The Integrity Recovery Society has been in the Prince George area for nearly 5 years, supporting individuals suffering from substance misuse. What we are is a complete abstinence program from all mood-altering substances. We are not a harm reduction program. We are the only complete abstinence program in northern British Columbia.

Being familiarized with Prince George over the few years it's not hard to notice the lack of resources or recovery places needed to combat addiction. Prince George is failing our vulnerable population in not addressing their needs in providing more recovery-related housing under the complete abstinence model. A model that was very successful before harm reduction and is still very successful today.

What I also witness is a small society called the Integrity Recovery Society leading the way in client success in Prince George. Our success over the last few years has gone unmatched.

On September 9th, 2024, Mayor Simon Yu and council members hold the fate of the Integrity Recovery Society. A vote to deny the application, is a vote to close the doors of the Integrity Recovery Society. The I.R.S. would not survive without the TUP and this action would shut the doors permanently. This would jeopardize the lives of many needing our services and those receiving our services today.

I'm also sure we can all agree, during this Opioid Crisis, now is not the time to be deleting any recovery services from the Prince George area, in fact we should be reaching out to acquire more services to support our vulnerable population. As it stands right now the Integrity Recovery Society is the only complete abstinence recovery housing program in all of northern British Columbia. The Integrity Recovery Society services are warranted.

There are two sides to recovery, either you are part of the problem, or you are part of the solution. Today, council gets to vote on which side they choose.

I, along with many other community members in College Heights, are looking forward to hearing of council's support in the Integrity Recovery Society receiving a TUP to begin recovery services.
