

Calls for Service – Bylaw Services & RCMP Operational Guideline (OG)

Corporate and Protective Services Division - Bylaw Services

Last Updated October 29, 2020

PURPOSE

To document revised and agreed-upon roles and responsibilities of Bylaw Services and RCMP respecting common calls for service to enable consistent understanding and operations for dispatch and responding personnel.

BACKGROUND

Bylaw Services have evolved to assume responsibility for some calls for service which the agency does not have the requisite mandate, training or authorities to attend. Continuance would invite risks and potential liability for Bylaw Enforcement Officers (i.e. safety) and the City of Kelowna, respectively.

Clear and documented understanding among RCMP, dispatch and Bylaw Services personnel directing how common calls for service are to be triaged, dispatched and subsequently responded to ensures the most appropriate agency responds, and enables more consistent and efficient approaches. The spirit and intent of this "Operational Guideline" (OG) is to appropriately redirect the primary response to select calls for service from Bylaw Services to RCMP, and to ensure a strong, collaborative working relationship between Bylaw Services and the RCMP. This OG aligns with City Council's priority of Community Safety and the City's corporate priority that "services, processes and business activities are transformed".

Appendix A was developed collaboratively among senior representatives of RCMP and Bylaw Services, in consult with the City's Director of Community Safety. Significantly, the Table represents a shift from current dispatch practices in respect to six common calls for service, specifically:

- 1) Removal of unwanted persons;
- 2) Noise complaints respecting parties;
- 3) Neighbours threatening;
- 4) Drug / alcohol activity public spaces;
- 5) Moving violations; and
- 6) Panhandling on highway boulevards

It is understood that implementation of these changes will result in a different response and may result in a different service level respecting the affected calls for service given these will be triaged in the context of other priority calls for the respective agencies.

Both parties commit to take the necessary steps to introduce and successfully implement this OG within their respective agencies on the effective date. Further, both parties commit to monitor the OG on an ongoing basis, to proactively and collaboratively resolve issues as they arise, and to ensure the spirit and intent of this OG is maintained. It is understood that either party (RCMP or Bylaw Services) may initiate a review or revision of this OG at any time, and that such review will occur in concert with the Director of Community Safety.

This OG will take effect on November 2nd, 2020 and will remain in effect until otherwise revised, suspended or terminated by the RCMP, Bylaw Services and the Director of Community Safety.
