

CITY OF PRINCE GEORGE
BYLAW NO. 9085, 2019

A Bylaw of the City of Prince George to amend “City of Prince George Official Community Plan Bylaw No. 8383, 2011”.

WHEREAS Council of the City of Prince George has, by Bylaw, pursuant to the *Local Government Act*, established an Official Community Plan;

AND WHEREAS Council has deemed it desirable that “Schedule B-6: Future Land Use” of “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended by re-designating the subject properties from Business District, Light Industrial to Community Facility, as shown on Appendix “A” to Bylaw No. 9085, 2019;

AND WHEREAS Council has deemed it desirable that “Schedule B-8: Community Facilities” of “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended to include the subject properties as “Community Facilities – Other”, as shown on Appendix “B” to Bylaw No. 9085, 2019;

AND WHEREAS a Public Hearing has been held in accordance with the *Local Government Act* and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended as follows:
 - a. That “Schedule B-6: Future Land Use”, be amended by re-designating Lots 1–6, District Lot 343, Cariboo District, Plan PGP43265 from Business District, Light Industrial to Business, District, Community Facility;
 - b. That “Schedule B-6: Future Land Use”, be amended by re-designating Parcel 1, District Lot 343, Cariboo District, Plan PGP41989 from Business District, Light Industrial to Business District, Community Facility;
 - c. That “Schedule B-6: Future Land Use”, be amended by re-designating Parcel 1, District Lot 343, Cariboo District, Plan 34353 from Business District, Light Industrial to Business District, Community Facility;

all as shown on Appendix “A” attached to and forming part of this Bylaw.

- d. That "Schedule B-8: Community Facilities", be amended to include Lots 1-6, District Lot 343, Cariboo District, Plan PGP43265, as "Community Facilities - Other";
- e. That "Schedule B-8: Community Facilities", be amended to include Parcel 1, District Lot 343, Cariboo District, Plan PGP41989, as "Community Facilities - Other"; and
- f. That "Schedule B-8: Community Facilities", be amended to include Parcel 1, District Lot 343, Cariboo District, Plan 34353, as "Community Facilities - Other";

all as shown on Appendix "B" attached to and forming part of this Bylaw.

- 2. This Bylaw may be cited for all purposes as "City of Prince George Official Community Plan Bylaw No. 8383, 2011, Amendment Bylaw No. 9085, 2019".


