I am writing to you as the City of Prince George and Regional District of Fraser Fort George nominee on the Barkerville Heritage Trust (BHT). As you know BHT was established in 2004 and officially took over the responsibility of managing Barkerville on April 1, 2005 under a Heritage Site Management Agreement (HSMA) with the Province of BC. Cottonwood House was added later as an additional heritage site.

The combined Barkerville/Cottonwood HSMA expires on March 31, 2025 and the Province has decided to put the contract out for bid under an open procurement process to commence later this fall. While BHT doesn't expect there to be many competing bids for this service, we are asking the stakeholder communities and organizations that founded BHT to provide us with a letter of support for our renewal bid.

BHT believes that it has a proven track record in heritage conservation, unique authentic historic interpretation, education and tourism attraction. In the past few years BHT has broadened its scope to embrace additional community engagement through Truth and Reconciliation and cultural diversity and enrichment programing.

BHT has also been successful in managing significant environmental and financial challenges in the past four years (including the Antler Creek fire this summer) and are confident that our proposal will demonstrate that BHT has a clear vision and a financially sustainable plan to ensure that Barkerville remains a world class heritage site in Canada.
