Purpose:

For Committee conversation this report is presented as a tool to facilitate conversation on the recent 2024 UBCM convention.

Background:

Topics where conversation may be helpful to define the next steps on advocacy include:

City of Prince George Resolutions:

• ESS Reception Center: UBCM considered the resolution to be too regional in focus. UBCM informed NCLGA that if endorsed at their spring convention, that they do not forward it to UBCM. Rather, NCLGA advocate on this issue. Staff was not familiar with this determination leading into the UBCM convention.

Next steps: Staff will connect with UBCM to better understand how this item fits into NCLGA's advocacy efforts and to share information on the proposal. Advocating for continued support in the form of prepositioned group lodging and ESS trailers as in 2024 is suggested in the interim.

 Taxation on School District Property: This resolution was not endorsed by the UBCM membership.

Next steps: As this is a province wide issue and the provincial advocacy body, UBCM, has considered and voted to not move forward with advocacy, staffs' suggestion would be to pause efforts on this item.
