In March 2018 we at Grasshopper Retail set out on a mission to open Prince George's first legal cannabis retail location at 421 George St. At that time we had no clue on how to open a small business, we learned a lot during this and assumed a lot of risk in the process not knowing whether we would be approved or not. With a lot of effort we were fortunate enough to get the support of City Administration and approval of a Temporary Use Permit to prove our business to the public. After 17 months of continuous effort we were able to open our doors to the public on July 11, 2019. Since then we have had our rezoning approved and although we continue to work through the complexities of being a downtown business owner we are happy to be driving traffic to our city's core.

In 2020 we found an ideal location at 6473 John Hart Highway (Birchwood Mall). When looking at this location we felt the zoning/land use was a good fit for our business. Again, we worked with City Administration to get their support for a rezoning application and are excited to say that we've just signed a renewal with the landlord to extend our business at that location. At our two current locations we employ 17 staff members.

Our third proposed location and the reason for your review today is that we have identified a 3<sup>rd</sup> Grasshopper location at 470 Ospika Blvd N. which conforms with the current use of the building and the OCP. In September 2024 we arranged a meeting with the Planning & Development Department of Prince George to ensure a Grasshopper Retail location would be met with support. After this meeting we felt encouraged and signed a lease with the new owners of this mixed-use commercial complex. Since then we have completed 90% of the renovations while applying for all the required permits with the City of Prince George. We have also collaborated with the building owners, enhancing the building itself by committing to add a 35 foot cedar planter on the south side of the building with an assortment of trees & shrubs and a new bicycle parking station on site. Located beside two staple tenants (7-ELEVEn & Liquor on 5<sup>th</sup>), we are very particular when selecting our proposed locations and are confident cannabis retail will complement the current businesses & neighbourhood. Our application includes 198 letter of support from current customers, neighbours of the area and the neighbouring businesses. This new location will create 8 more jobs for residents of Prince George during economic uncertainty.

For this application we encourage you to set aside any preconceived notions of cannabis you may have and instead focus on the land use for this location as it is a legal business and our application is strictly on land-use for the site.
