D.3 Library Skylight Renewal - Budget Amendment

That Council APPROVES a budget amendment to increase the 2025-2029 Financial Plan for Project #3457 Library Skylight Renewal from \$875,000 to \$1,125,000 with the additional\$250,000 to be funded from both the Canada Community Building Fund for \$200,000 and the General Infrastructure Reinvestment Fund for \$50,000, as described in the report to Council dated April 17, 2025 from the Director of Civic Facilities and Events, titled "Library Skylight Renewal - Budget Amendment".

That Council POSTPONES consideration of the main motion to the May 26, 2025 Regular Council Meeting and DIRECTS Administration to return at that meeting a comprehensive report containing the following information for Project #3457: Library Skylight Renewal:

- A line-by-line breakdown of the \$250,000 budget increase, specifying cost drivers (e.g., material costs, labor, contractor fees).
- A line-by-line breakdown of the original \$875,000 project budget, detailing all cost components to enable thorough analysis and establish a standard for future budget transparency.
- Supporting evidence justifying the \$250,000 increase, including vendor quotes, market data, cost escalation reports, or other relevant documentation.
- A detailed explanation of how the project aligns with council's strategic priorities and delivers measurable value to Prince George taxpayers.
