## Recommendation(s):

That Council RECEIVES FOR INFORMATION the report dated April 23, 2025 titled "Snow and Ice Control Costing Breakdown (November 1st to December 31st, 2024), from the Director of Civic Operations.

## Purpose:

This report is presented to Council in response to a Council resolution directing administration to provide a breakdown of the Snow and Ice Control expenditures from November 1<sup>st</sup> to December 31<sup>st</sup>, 2024.

#### Discussion:

Snow and Ice Control is a significant cost for the City of Prince George. The costs associated with having staff on hand and at the ready is approximately \$133,000 per week. This excludes the cost of any snow events or overtime. Contracted equipment retainers are an additional approx. \$57,500 per month. Additional costs associated with Snow and Ice Control include internal equipment and contractors, as well as traction materials and ice melting chlorides. See Table 1.

Three (3) Priority 3 snow events occurred between November 1<sup>st</sup> and December 31<sup>st</sup>, 2024. See Table 2 below for costs associated with each event, as well as the snowfall accumulation during the event and the duration to clear. The total cost as a direct result of these events was approximately \$1,680,000.

Snow and Ice Control at City-owned facilities is also funded by the Snow and Ice Control Budget. The threshold for a snow event is lower for these facilities (50mm) and was triggered three (3) times for a total cost of approximately \$380,000. See Table 3 for a detailed breakdown.

Total snow accumulations between November 1<sup>st</sup> and December 31<sup>st</sup>, 2024 are shown below on Table 4. Even the most insignificant amount of snow results in operating and maintenance activities to ensure safe passage for pedestrians and motorists throughout the City.

The purchase of winter traction materials is an often-overlooked cost associated with Snow and Ice Control. The total cost of all winter road maintenance materials and chlorides for 2024 was \$743,589.

Another cost drawing from the Snow and Ice Control Budget is retroactive employee pay. As a result of the ratification of the new Collective Agreement, individuals returning to the Roads Division for their winter seasonal positions were entitled to retroactive pay. The cost of this was approximately \$296,000. This cost was borne by the Snow and Ice Control Budget and was incurred prior to the end of the 2024 fiscal year.

During the shoulder season, at the beginning and end of winter, crews are tasked with a variety of maintenance projects including ditching, brush clearing, flailing, and culvert replacement. These tasks are funded under Alternate Snow, which is part of the overall Snow and Ice Control Budget.

Snow and Ice Control is a Council priority as identified in the Snow and Ice Control Policy.

### Summary and conclusion:

Regardless of snow accumulation during any given day, daily operating and maintenance procedures are required to maintain personnel and equipment readiness, limit liability to the City, and provide safe passage to users of City owned roads, sidewalks, and facilities.

Annual costs continue to rise with inflation, particularly since the onset of the pandemic. Additionally, the ongoing strain on the heavy equipment and operating industry in northern BC continues to have a negative impact on contractors' ability to retain qualified personnel, which in turn increases costs.

Administration is continuously exploring cost saving measures for potential implementation, while maintaining the quality of service that residents and visitors have become accustomed to. We are a northern city that sees significant annual snowfall, and we continue to provide above average snow clearing service to our residents.
