# OFFICIAL COMMUNITY PLAN BYLAW NO. 8383, 2011 AMENDMENT BYLAW NO. 9085, 2019

Subject Properties - 805/855 1st Avenue and 190 Ontario Street

The City of Prince George is considering an amendment to the City of Prince George Official Community Plan (OCP) Bylaw No. 8383, 2011 to amend Schedule B-6: Future Land Use from Light Industrial to Community Facility, and adding the subject properties to Schedule B-8: Community Facilities. This OCP amendment also includes a rezoning application (Bylaw No. 9086).

The City of Prince George will be hosting a public meeting and information session on the proposed OCP amendments. This information session will occur at City Hall in the **2nd Floor Conference Room on January 15, 2020 from 6:00 pm to 7:30 pm**. A presentation will commence at 6:30 pm.
