

CITY OF PRINCE GEORGE
BYLAW NO. 9514, 2024

A Bylaw of the City of Prince George to rezone certain lands and to amend "City of Prince George Zoning Bylaw No. 7850, 2007".

WHEREAS pursuant to the provisions of Section 479 of the *Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that a 22.7 ha portion of the subject property be rezoned from AG: Greenbelt and P6: Special Institutional to M2: General Industrial and a 3.3 ha portion of the subject property be rezoned from AF: Agriculture and Forestry and P6: Special Institutional to AG: Greenbelt, to facilitate an industrial construction services company on the subject property, or other uses, pursuant to the M2: General Industrial and AG: Greenbelt zoning designations;

SUBJECT PROPERTY: 880 Guay Road

AND WHEREAS a Public Hearing was held in accordance with the *Local Government Act* and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That "City of Prince George Zoning Bylaw No. 7850, 2007", be amended as follows:
 - a. That a 22.7 ha portion of Lot 1 Except: Part Subdivided by Plan BCP12745, District Lot 955, Cariboo District, Plan PGP39143, be rezoned from AG: Greenbelt and P6: Special Institutional to M2: General Industrial; and
 - b. That a 3.3 ha portion of Lot 1 Except: Part Subdivided by Plan BCP12745, District Lot 955, Cariboo District, Plan PGP39143, be rezoned from AF: Agriculture and Forestry and P6: Special Institutional to AG: Greenbelt,as shown on Appendix "A", attached to and forming part of this Bylaw.
2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
3. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.

4. That this Bylaw may be cited for all purposes as "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9514, 2024".

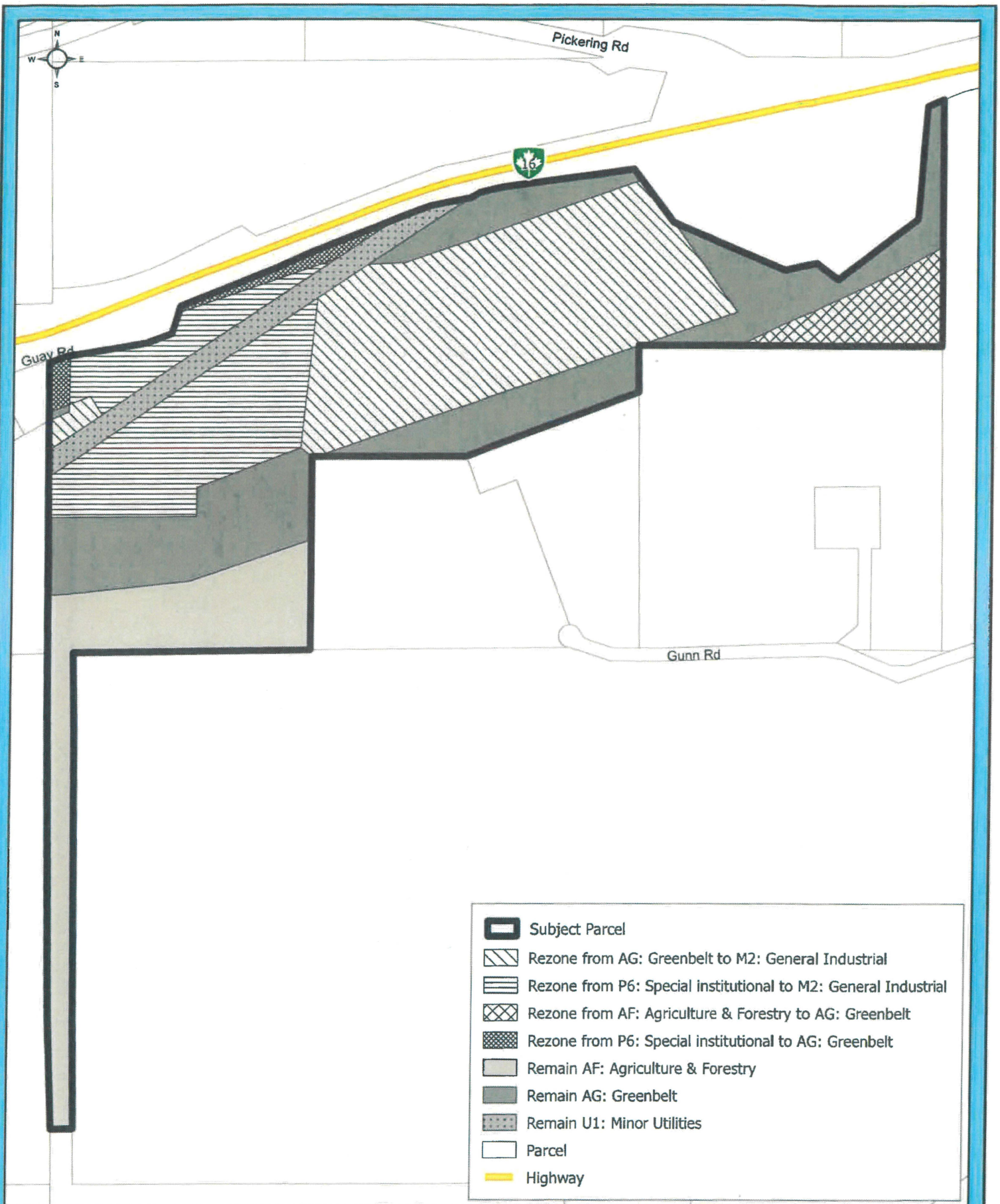
