On behalf of OVERhang Education Centre Ltd, I am keen to throw my support behind locals JP Asquith and Rebecca Menge in their application for a Temporary Use Permit Application (TU000112) which would allow their company, Fir Haven, to open a Nordic Spa.

It is critical that Prince George support initiatives by entrepreneurs, particularly in the tourism and hospitality sectors, to create a critical mass of opportunities for locals and tourists to engage in unique ticketable recreational activities and attractions. This is currently a sector with few local options for tourists to book well ahead (or book when already in town); visitors need to find attractions to keep them here for a few days.

Now imagine a package experience in which far-flung visitors are brought to the climbing gym for a climbing or rappelling adventure, then out to the Fir Haven Nordic Spa to relax their muscles, followed by a riverside dinner and wine flight at the winery, wrapped up with a stay at a local hotel.
