A Bylaw of the City of Prince George to authorize the cancellation of a Land Use Contract.

- 2. That "Authorization Issuance Land Use Contract No. LU 3-72, Bylaw No. 2400, 1972", is hereby repealed.
- 3. That the Mayor and Corporate Officer are hereby authorized to sign and seal any documents necessary to effect the discharge of "Authorization Issuance Land Use Contract No. LU 3-72, Bylaw No. 2400, 1972", registered under the Land Title and Survey Authority registration number G12975 and give this Bylaw effect, and to deliver the same as acts and deeds of the City of Prince George.
- 4. This Bylaw may be cited for all purposes as "Authorization Issuance Land Use Contract No. LU 3-72, Bylaw No. 2400, 1972, Discharge Bylaw No. 9130, 2020".
