**SUBJECT:** 2021 Permissive Tax Exemptions

**ATTACHMENT(S):** Recommended 2021 Permissive Tax Exemptions

**RECOMMENDATION(S):**

That the Standing Committee on Finance and Audit recommend that Council approve the 2021 Permissive Tax Exemptions itemized in the attachment to the report dated August 21, 2020 from the Director of Finance titled “2021 Permissive Tax Exemptions”.

**PURPOSE:**

The report provides the Standing Committee on Finance and Audit with an itemized list of the applications that meet the criteria for 2021 Permissive Tax Exemptions and requests that the Committee recommend that Council approve the exemptions.

**STRATEGIC PRIORITIES:**

Sustainable Finance Guideline 5.5 indicates that Permissive Tax Exemptions are a means for Council to support organizations within the community to further Council’s objectives of enhancing quality of life and delivering services economically. There is no obligation on Council’s part to grant exemptions.

**POLICY/REGULATORY ANALYSIS:**

Permissive Tax Exemptions are generally granted for non-profit organizations, places of public worship, and municipal tenants. The total estimated value for the tax exemptions in this report’s recommendations is \$1,939,472 or 1.72% of the tax levy (based on 2020 tax rates and assessment values). The exact amount of these exemptions will not be known until the time that BC Assessment releases the revised property tax roll in 2021.

**Non-Profit Organizations**

The estimated value of exemptions recommended for non-profit organizations for 2021 is \$1,139,030; the value of new exemptions recommended by Administration is \$23,829. The new non-profit applications are:

1. 90-06350-260 (land only), 90-06350-255 (land only), 90-06300-000 (Main Terminal) - Prince George Airport Authority (PGAA) – A large portion of the Airport lands are already exempt under *The Canada Airports Act*. The PGAA is seeking exemption on other pieces of property that support the organization’s activities. The basis of the application is that the

PGAA provides access to distant emergency health care services and provides a transportation network as well as makes space available for other organizations to use. However, the PGAA is not directly administering any community benefit programming that fits the requirements for exemption.

2. 00-03558-000 – Sources Community Resources Society – Services provided help to promote wellness. Behaviour support program provides services to identify skill deficits and to create comprehensive support plans to assist caregivers in teaching new skills and replacing challenging behaviour. The B.A.S.I.C. program provides 1:1 intervention with children, adolescents and adults with developmental disabilities. Independent living programs work with adolescents who are transitioning to adulthood. Youth workers work 1:1 with adolescents to teach them skills to connect with services and resources they will require as adults. The Family Preservation program supports at risk families who either had children removed or are at risk of having them removed and connects them with resources and work in the community.
3. 00-03597-000 – Prince George Italian Club – Services provided are: Italian Cultural Club, school for Italian language and cooking, Italian dinner events, catering and rental facility, seasonal cooking and bake sales to all residents of Prince George, providing orientation for newly arrived Italian immigrants, networking and socializing of residents of Italian descent, and venue for visits from the Italian Consulate staff for renewing and issuing of Italian passports.
4. 00-03562-000 – Carrier Sekani Tribal Council – CSTC is a non-profit organization that assists the CSTC communities to the best of their abilities. These communities play an integral role in the economy of Prince George and surrounding district. Fisheries program receives annual funds from DFO to assist with local salmon runs and endangered sturgeon runs. Archives Department receives grant monies to support staff. Technical Services Unit receives funding from Indigenous Services Canada to assist CSTC communities with water and sewer and other infrastructure.

***Administration recommends that the Sources Community Resources Society and Italian Club applications be APPROVED.***

***Administration recommends that the Prince George Airport Authority and Carrier Sekani Tribal Council applications be DENIED as they do not meet the requirements for exemption at the time of this report.***

### **Places of Public Worship**

Places of Public Worship generally receive statutory tax exemptions. The Permissive Exemption they apply for relates to the hall and the land surrounding the school or place of worship. The estimated value of exemptions for places of worship for 2021 is \$270,202.

There are no new applications for exemption for Places of Worship.

### **Municipal Tenants**

Municipal Tenants who meet the criteria of the Permissive Tax Exemption program can apply if the property taxes are not already a financial consideration as part of their lease agreement. The

estimated value of the exemptions recommended for municipal tenants in 2021 is \$530,240. There is no change in the recommended list of properties for exemption from 2020.

As in prior years, BC Assessment will assess City tenants for commercial areas and those areas will be taxable. The taxable portion, which is unknown at this time, is not reflected in this report. Therefore, the estimated tax assistance for City tenants may be slightly overstated.

There are no new applications for exemption from municipal tenants.

**SUMMARY AND CONCLUSION:**

The recommended permissive exemption amount for 2021 (\$1,939,472) does not include statutory exemptions provided under Section 220 of the *Community Charter*. Administration recommends that the Standing Committee on Finance and Audit recommend that Council approve the itemized list in the attached 2021 recommended permissive tax exemptions.
