

There was point made that cannabis is a gateway drug. I believe it is not. Cannabis was smoked illegally in the 60's, 70's and so on, and those smokers who were once called hippies are now executives and judges. One colleague of mind, a lawyer, who worked at Redacted told me that he smoked cannabis with half the judges across the street. The big bad drug of the day was acid, and it was not an addictive drug. The youth who smoke cannabis today are not likely to turn to acid because it has lost favour as a hard drug of choice.

Where there is abuse of hard drugs in this city it is meth, crack, heroin, and prescribed pills. Meth, crack, and heroin are introduced by big bad drug dealers who are notorious criminals. Pills are introduced by doctors. There are countless people who still buy cannabis from the black market. Cannabis from that market sometimes contain fentanyl. Hundreds of youth have been overdosing on fentanyl in BC in the past month. Those sellers in the black market do not pay taxes.


There are already legal cannabis stores in Prince George, as well as government cannabis stores. If the argument that cannabis is a gateway drug and therefore Epik should not be able to open its doors, is to be legitimate, then it must be consistent with the reasoning that went behind allowing the other cannabis stores to open in this city.

There was a point made that Epik would be within a certain number of metres to another cannabis store. I notice that there are several law firm businesses in downtown Prince George, many of whom are very close in proximity to one another. There seemed to be no backlash against the lawyers huddling close.

One of the missions of the city is to enhance local conditions that support existing businesses and attract new ones, with a focus on clean energy. Epik is a new business, that will be able to employ a couple dozen people, as well as pay taxes, and provide a service to residents. It focuses on clean energy, inasmuch as any other office building in Prince George does. I learned that one position put forward opposing Epik, was that the other cannabis stores are not doing that well. Target came to Prince George. It did not do that well. Lowe's came to Prince George. It did not do that well. Yet, Prince George did not oppose giving those businesses a chance.




