## CITY OF PRINCE GEORGE BYLAW NO. 9134, 2020

A Bylaw of the City of Prince George to rezone certain lands and to amend certain text within "City of Prince George Zoning Bylaw No. 7850, 2007".

**WHEREAS** pursuant to the provisions of Section 479 of *the Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

**WHEREAS** the Council of the City of Prince George has deemed it desirable to amend "City of Prince George Zoning Bylaw No. 7850, 2007" by adding "Housing, Supportive" as a principal use within the RM5: Multiple Residential zone on the subject property:

  - a. that Section 10.13.2 "RM5: Multiple Residential" be amended by adding "Housing, Supportive only on Lot 6, District Lot 343, Cariboo District, Plan 18815".
- 2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
- 3. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 4. That this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 9134, 2020".
