PURPOSE:

The BC Games Society recommended that up to eight (8) persons form a Nomination Committee for the purpose of recruiting candidates for the President, Vice-President and other Board of Director positions for the Prince George 2022 BC Summer Games Society. The purpose of this report is to inform Council that the Nomination Committee has fulfilled its mandate.

BACKGROUND:

On March 10, 2017, the BC Games Society awarded the 2022 BC Summer Games to the City of Prince George. The bi-annual Games are an important step in the development of high performance athletes, with some continuing onto national and international competition. The 4-day celebration will bring vibrancy and energy to our City with over 3,500 athletes, coaches and officials, and spectators expected to come from around the Province.

At the November 26, 2020 meeting Council directed Administration to establish, the 2022 BC Summer Games Nomination Select Committee (the "Committee"). The Committee has been selected and has held several meetings between January 18, 2021 and April 30, 2021.

The following eight (8) members compose the Committee:

- 1. One (1) member of Council, Mayor Lyn Hall;
 - Three (3) members of City of Prince George Administration:
 - Walter Babicz, Acting City Manager;
 - Adam Davey, Director of Community Services and Public Safety; and

- Brad Beckett, Senior Manager of Prince George Events Group
- 3. Up to four (4) members including, as possible, representation from:
 - Dayi Clayton Pountney, Lheidli T'enneh First Nation;
 - Veronica Haddon, Engage Sport North;
 - Ron Polillo, School District No. 57; and
 - Doug Bell, Tourism Prince George.
