# D.1 Presentation of the City of Prince George Audit Planning Report for the year ended December 31, 2020

Mr. Corey Naphtali, Lead Engagement Partner, and Ms. Micaela Roque, Partner, KPMG, LLP attended the meeting via Zoom and provided a PowerPoint presentation regarding the City of Prince George's Audit Planning Report for the year ended December 31, 2020. The presentation included information on areas of the audit focus, audit risks, materiality, audit technology, key deliverables and milestones, auditing standards, current developments in the Public Sector Accounting Standards and KPMG resources.

Discussion commenced regarding areas of audit focus, including tangible capital assets, revenue and deferred revenue, audit procedures for evaluating risk within existing internal processes, and the Public Sector Accounting Standard effective for fiscal years beginning on or after April 1, 2022 with respect to Asset Retirement Obligations.
