Prince George Homeless / Displaced Person Survey May 29 - June 11, 2021

Created and conducted by Will Lewis

This independently created and conducted survey was done by myself, Will Lewis, a citizen of Prince George, in order to find out what other people in the community thought about certain civic issues. It allowed people to anonymously share their feelings, and helped me to gain a wide and honest overview of public opinion. For the purposes of this survey, homeless and displaced persons are used interchangeably.

The survey was neither professional, nor scientific. Justifiably, it drew intense criticism, but it also received expressed gratitude. My apologies for unconscious biases and questions that could have (and should have) been worded in a much better manner. Especially questions 7, 8, 25 and 27. Hopefully my mistakes will inspire more professional efforts.

The survey ran for 14 days, from May 29th until June 11th, 2021, and was distributed only through social media, It contained a total of thirty six questions. No personal information was collected. Questions about sex and age were for statistical purposes only.

The survey received a total of 530 participants.
