

CITY OF PRINCE GEORGE
BYLAW NO. 9178, 2021

A Bylaw of the City of Prince George to amend “City of Prince George Official Community Plan Bylaw No. 8383, 2011”.

WHEREAS Council of the City of Prince George has, by Bylaw, pursuant to the *Local Government Act*, established an Official Community Plan;

AND WHEREAS Council has deemed it desirable that “Schedule B-6: Future Land Use” of “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended by re-designating a portion of the subject properties from Rural Resource to Neighbourhood Residential, as shown on Appendix “A” to Bylaw No. 9178, 2021 and “Schedule B-4: Growth Management” of “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended by re-designating a portion of the subject properties from Rural Resource to Infill, as shown on Appendix “B” to Bylaw No. 9178, 2021;

SUBJECT PROPERTIES: **3751 and 3777 Barnes Drive**

AND WHEREAS a Public Hearing has been held in accordance with the *Local Government Act* and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That “City of Prince George Official Community Plan Bylaw No. 8383, 2011”, be amended as follows:
 - a. That “Schedule B-6: Future Land Use”, be amended by re-designating Lot 1, District Lot 9263, Cariboo District, Plan 16592 and Lot 2, District Lot 9263, Cariboo District, Plan 16592 from Rural Resource to Neighbourhood Residential, as shown on Appendix “A” attached to and forming part of this Bylaw; and
 - b. That “Schedule B-4: Growth Management”, be amended by re-designating Lot 1, District Lot 9263, Cariboo District, Plan 16592 and Lot 2, District Lot 9263, Cariboo District, Plan 16592 from Rural Resource to Infill, as shown on Appendix “B” attached to and forming part of this Bylaw.
2. That this Bylaw may be cited for all purposes as "City of Prince George Official Community Plan Bylaw No. 8383, 2011, Amendment Bylaw No. 9178, 2021".

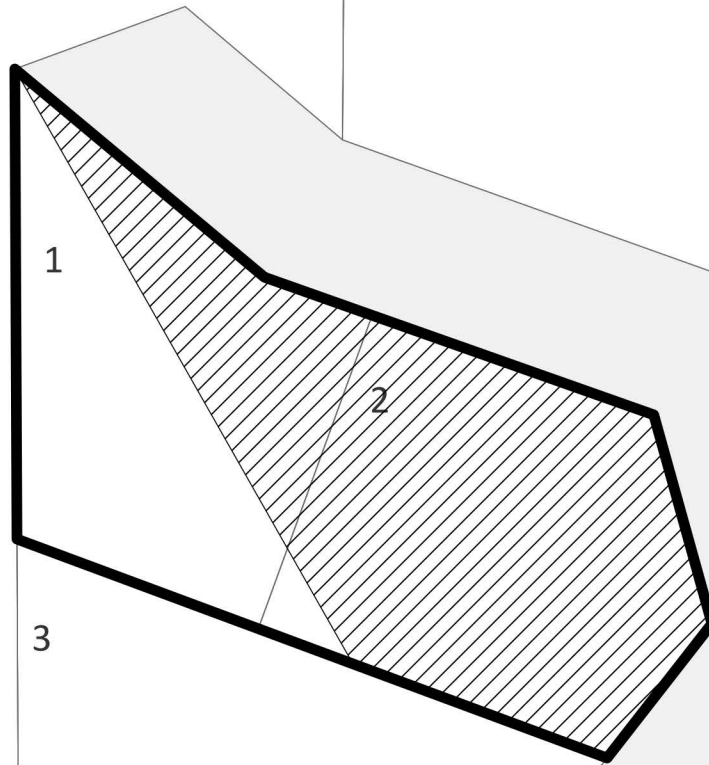
